Operating Engineers work in all types of weather elements and the majority of work is performed outdoors. Length of Apprenticeship Four (4) years (approximately) - Minimum of 600 hours of on-the-job training. Apprentices must complete 240 classroom hours. (80 hours of classroom instruction for the first 3 years)
